A STAR Health Guide: Transitioning Youth and Former Foster Care Members



Superior HealthPlan (Superior) wants to make sure that if you're aging out of foster care you can still get great healthcare. That's why STAR Health members will get the same benefits and services from Superior after turning 18. These services will continue until you are 21.

Eligibility

Just update your address by calling 2-1-1 or by visiting www.YourTexasBenefits.com. As long as you are between 18 and 21 and a Texas resident, your STAR Health benefits will continue.

Benefits and Services

Even though you are no longer in foster care, you will have the same benefits. The main difference is that you will be your own Medical Consenter. This means Superior will work with you to meet your healthcare needs instead of contacting a Caregiver or Caseworker. The adolescent to Adult (a2A) Program

Now that you are 18, you can participate in the a2A program. This is an extra benefit called a value-added service. This program offers you rewards for taking control of your health. Members can earn up to \$160 a year. This includes:

- \$30 for each dental exam (up to two exams per year).
- \$25 for getting your annual Texas Health Steps checkup. An extra
 \$25 if completed within 30 days of your 18th birthday.
- \$20 for getting an annual flu shot.
- \$20 for getting an annual well-woman checkup (females only).
- \$10 for completing a general health screening within 30 days of your 18th birthday.

Financial Help

You can now get help with tuition and fee waivers. This means you will not have to pay tuition and fees at a Texas state supported school or college! Call 2-1-1 to request an application or visit
